Shocking Facts Uncovered by videos of Planned Parenthood

Pro-life videographers from the Center for Medical Progress posed as fetal tissue buyers in meetings with Planned Parenthood executives and medical personnel. The first of 12 videos was released on July 14, 2015. The project director is 26-year-old David Daleiden. Planned Parenthood Federation of America (PPFA) has hired crisis management firm SKDKnickerbocker to squelch and spin the facts.

Key revelations from CMP undercover videos:

1. Planned Parenthood has harvested and sold fetal organs.

The Planned Parenthood videos show more than one abortionist haggling over prices for fetal organs. It is illegal to sell fetal tissue for a profit. The videos raise questions on whether the organization has violated the law. Planned Parenthood's first line of defense was claiming their fetal tissue transactions did not generate financial gain. Spokespersons claimed revenue from organ transactions just recouped the shipping and handling costs. Then, facing mounting public outrage, in November Planned Parenthood announced that it still harvests fetal organs but would not accept payment for these organs.

2. Planned Parenthood medical personnel talked jokingly about aborted babies.

Planned Parenthood's Dr. Mary Gatter joked that she wanted a "Lamborghini" in exchange for fetal organs when negotiating prices. Dr. Gatter is Medical Director for Planned Parenthood Pasadena and San Gabriel Valley and also serves PPFA as the chair of their Medical Director's Council. She is PPFA's second highest physician.

3. "Abortions" sometime result in live births.

In the ninth video, Perrin Larton, Procurement Manager for Fetal Tissue for Advanced Bioscience Resources (ABR), a Planned Parenthood contractor, explained what she encountered herself. "I literally have had women come in and they'll go in the O.R. and they're back out in three minutes, and I'm going, What's going on? Oh yeah, the fetus was already in the vaginal canal whenever we put her in the stirrups, it just fell out."

4. Abortion providers sometimes use the cardiotoxic drug digoxin to kill babies in the womb.

This is revealed by Dr. Deborah Nucatola in the first video. Dr. Nucatola is the Senior Director of Medical Services for Planned Parenthood Federation of America. Nucatola is PPFA's highest ranking physician. "There's a group of people who just use it so they have no risk of violating the Federal Abortion Ban. Because if you induce a demise before the procedure, nobody's going to say you did a 'live' – whatever the federal government calls it. Partial-birth abortion." After inducing a heart attack that kills the baby, Planned Parenthood's top physician explained that many abortionists think it makes completing the abortion easier.

5. Digoxin renders fetal tissue unusable for harvesting, so crushing the fetus is preferable.

Planned Parenthood's Dr. Mary Gatter explained in the second video that many drugs used to kill babies in the womb taint the tissue, making the fetal tissue unusable for research. This makes clear why Dr. Nucatola explained in the first video that she usually crushes the baby's head and lower body with forceps inside the womb before removing the pre-born baby.

6. One baby born intact had its face cut off for brain harvesting.

Holly O'Donnell, a former technician for Stem Express, explained in the 7th video that a nearly intact late-term fetus aborted at Planned Parenthood's clinic in San Jose, CA, was instructed to harvest brain tissue from a dead fetus. "She gave me the scissors and told me that I had to cut down the middle of the face. I can't even describe what that feels like." O'Donnell recounted.

7. Abortionists can make the heart of an aborted baby beat.

"And she just taps the heart, and it starts beating," O'Donnell continued: "And I'm sitting here and I'm looking at this fetus, and its heart is beating, and I don't know what to think."

Major news outlets refuse to cover the videos. The mainstream press provides protection for Planned Parenthood like a football team's offensive line protects their quarterback.

Potential felony violations uncovered by CMP videos:

1. Profiting (financial gain) from the sale of fetal tissue. This would be selling tissue for prices greater than the cost of extraction, storage, and transportation.
2. Illegal abortion practices. A. Partial birth abortion – live fetus is delivered breech from the mother with the exception of the head. B.
3. Altering the abortion procedure for the purpose of harvesting higher quality fetal organs.
4. Violation of consent standards from the mother for the severing and sale of fetal organs.

Whether criminal or not, Planned Parenthood actions reveal a heartless brutality that should disqualify them from support from BOA or any corporation.
