



### Petition to members of the board of directors of Planned Parenthood of Greater Texas

PPGT has branches in Austin, Dallas/Fort Worth, Paris, Tyler, and Waco.

**We call on board members of Planned Parenthood of Greater Texas (HQ in Austin) to cancel plans to reestablish your Waco branch as the regional abortion center for Central Texas. Abortion in Waco during 1994-2013 brought over 19,000 deaths, immense harm to women, strong community opposition, and declining community respect for Planned Parenthood.**

Planned Parenthood opened an abortion facility in January of 1994 in the face of intense community opposition. During the 19 years of Planned Parenthood abortions in Waco, over 19,000 babies in the womb lost their lives. Along the way, Planned Parenthood's community reputation suffered a steep decline.

By the time PPGT's Waco abortion facility closed in 2013, Planned Parenthood had shifted from an organization with broad community respect to an institution at the margin of public life.

The return of abortion to Waco will benefit no one. Residents in dozens of counties surrounding Waco reject the resumption of abortion. They cringe at the thought of the shedding of innocent blood of defenseless babies in the womb.

We appeal to board members of Planned Parenthood of Greater Texas in the strongest terms to fully consider the realities of Central Texas and terminate plans to reestablish your Waco branch as "the abortion city" for Central Texas.
