Planned Parenthood profits?

According to Dr. Deborah Nicotula, senior director of medical services at Planned Parenthood, hearts, livers and lungs are among the most in-demand body parts taken from aborted babies. Allegations that Planned Parenthood harvests babies' body parts for sale raises questions:

Should Planned Parenthood be selling the body parts of aborted babies? If so, why? If not, why not?

Cecile Richards, president of Planned Parenthood Federation of America, states, "I want to be really clear. The allegation that Planned Parenthood profits in any way from tissue donation [hearts, livers, lungs] is not true."
