

#### **Bubble gum & abortion**

Regarding Donna Myers' recitation of supposed facts, including the low incidence of abortions performed by Planned Parenthood: She can cite "facts" from Factcheck.org all she wants, but if one doesn't understand how these facts are derived, one can be deceived.

You are outraged that I sell assault weapons to young people, but I can say, "Oh, no, I run a candy store and 97 percent of my activities are harmless candy sales!"

We at Pro-Life Waco learn of these Planned Parenthood tricks from great guest speakers we get like Abby Johnson and Carol Everett, former (and reformed) directors from the Planned Parenthood hierarchy. And that's the service that Pro-Life Waco director John Pisciotta works to provide — shedding the light of truth on this evil organization.
