While the pro-life community of the Waco area is ready to respond to new challenges and opportunities, some events occur on a continuous basis.

The first Sunday of each month is **Life Chain Sunday** from 2 to 3 p.m. at the intersection of Valley Mills and Waco Drive.
We hold "G-rated" signs about the reality of abortion in our community. One sign reads, "Honk if you're pro-life."We hear a lot of honking and see many "thumbs up" from the thousands of cars passing by.

For **Second Sunday Gatherings**, an average of seventy pro-lifers gather at St. Mary's Parish Hall for a noon-hour meal, fellowship, and a meeting from 1 to 2 p.m. for education and action planning.

Witness on abortion day is each Thursday while Planned Parenthood Waco administers surgical abortions at its Columbus Avenue abortuary. Christians from several pro-life ministries stand and pray outside the abortuary. Our hope is to guide women away from their appointments with death and heartbreak.

March 31 Komen Race supports PP Waco



The 2007 Susan G. Komen Central Texas Race for the Cure was held on Saturday, March 31 in downtown Waco.

Among the almost \$250,000 in local grants, Komen of Central Texas again awarded \$45,000 to Planned Parenthood of Central Texas for mammography and follow-ups.

This financial "arrangement" polishes the image of Planned Parenthood while tarnishing the image of Komen. Why would a foundation dedicated to helping women survive breast cancer partner with the nation's leader in the abortion industry?

Pro-Life Waco continues to educate the public about the unfortunate and unnecessary alliance between the Komen Foundation and Planned Parenthood Waco.

In addition to grants to Planned Parenthood, Komen Foundation also refuses to warn women about the well-documented link between abortion and the onset of breast cancer. Clearly, women deserve to know all about risk factors for breast cancer.

Ink attack on Life Chain results prosecutions

Just as the May 6 Life Chain was wrapping up, a black SUV came to a stop beside six prolifers remaining. The male passenger pulled out two large water pistols and showered the prolifers with a mixture of ink and water.

The ink hit clothing and signs of four prolifers. Another who was not struck noted the license plate number for the report to the Waco Police Department.

On Friday, May 18, the 20-year-old female driver of the vehicle and the 23-year-old passenger/shooter were arrested, charged, released from McLennan County Jail on bonds of \$1.000 each.

The pair pleaded guilty on July 27 in the County Court of Judge Michael Gassaway. Each was fined \$100, must pay restitution to the ink-stained pro-lifers, and is on 12-months deferred probation.

We appreciate the swift action of the Waco PD and the McLennan County judicial system.

Waco Planned Promiscuity 18th annual Nobody's Fool




For almost two decades, the Planned Parenthood business plan has included a children's conference to promote their "anything goes" view of sexuality. The Nobody's Fool teen conference took place on Wednesday, July 25 at the Waco Convention Center.

Sidewalk persuaders from various churches and ministries engaged parents to reveal the truth about Planned Parenthood. Several groups with children planning to attend decided to depart when they learn about the PP's heritage of promoting "free sex."

The second pro-life challenge on the occasion of Nobody's Fool was the Pro-Life Waco news conference on Planned Parenthood failure to report underage sex or statutory rape. Over 50 pro-life allies stood with Barbara Myers and John Pisciotta, co-directors of Pro-Life Waco, at the news conference. Two Waco television stations and the *Waco Tribune-Herald* covered the news conference.

The issue of compliance with mandatory reporting of statutory rape has many legal implications. Moreover, there are the minds, bodies, and souls of the children being raped.

PLW acquires and transfers property to local church



In March of 2007, Pro-Life Waco acquired property directly across the street from Planned Parenthood at Ross Ave. and 12th Street from a pro-life friend. The property includes two buildings, each with 1,200 square feet of floor space.

PLW improved the property and dealt with the City of Waco over a condemnation.

The purpose of acquiring the property was to find some other church or organization which would want to carry out Christian pro-life, pro-family ministry.

In September, the property was transferred to a local church. We look forward to seeing the blessings that will flow from their use of the property for ministry in a neighborhood with enormous needs.
